





An esteemed academic, he holds adjunct and honorary professorships at Taylor's University and IUKL and serves on the advisory board of UCSI University's Tan Sri Omar Centre for STI Policy Studies.

A prolific writer, he has authored over 10 books and edited more than 20 publications, focusing on governance, integrity, and anti-corruption.
